- The duly filled EOI Form, accompanied with all requested documents, will be treated on the *first-come, first-serve* principle.
- **After the deadline of 30 November 2019**, EOI Forms which could not be processed will be rejected.
- A notification/reference number will be given upon submission of each duly filled and signed EOI Form.
- Read carefully this EOI Form and submit all requested materials.
