



# Central Electricity Board (CEB)

## ENLISTMENT / VACANCY

Applications are invited from suitably qualified candidates for the following enlistment and vacancy:

### 1. Enlistment - Cadet Engineer (Electrical and / or Electronics or Electronics and Communication)

#### Qualification Requirements

- A degree in Electrical and/or Electronics or Electronics and Communication Engineering from a recognised University, or an alternative qualification acceptable to the Board.
- Registered with the Council of Registered Professional Engineers (Mauritius).

### 2. Enlistment - Cadet Engineer (Mechanical)

#### Qualification Requirements

- A degree in Mechanical Engineering from a recognised University, or an alternative qualification acceptable to the Board.
- Registered with the Council of Registered Professional Engineers (Mauritius).

#### Salary for Enlistment as Cadet Engineer

During cadetship, which will be for a maximum period of 24 months, candidates will be paid a stipend in the scale of Rs 49600 x 1425 – 51025 x 1700 – 52725 p.m. + increases at the approved rates. They will also be provided with all facilities to undergo training in CEB's various technical and engineering fields of activities.

Upon successful completion of the cadetship programme to the satisfaction of Management, the Cadet Engineers will be considered for appointment as Engineer.

The salary scale for the post of Engineer is Rs 52725 x 1700 – 66325 x 2600 – 71525 x 2900 – 91825 p.m. + increases at approved rates.

#### Bond

The selected candidates will be required to subscribe to a bond effective as from the date of enlistment, as per the conditions laid down by the CEB.

### 3. Enlistment - Trainee Engineer (Electrical / Electronics or Communication)

With a view to helping Engineering graduates to secure registration with the Council of Registered Professional Engineers (Mauritius), the CEB is prepared to offer a two-year pre-registration training in the following fields:

- i) Electrical and / or Electronics or Electronics and Communication Engineering
- ii) Mechanical Engineering

#### Qualification Requirements

- A degree in Electrical and / or Electronics or Electronics and Communication Engineering or Mechanical Engineering from a recognised University, or an alternative qualification acceptable to the Board.
- A certificate of eligibility for registration as Professional Engineer from the Council of Registered Professional Engineers (Mauritius).

#### Stipend

Rs 25,700 p.m + increases at approved rates.

### 4. Vacancy - Post of Draughtsman

#### Qualification Requirements

- i) Pass in 5 subjects including English, French and Maths at Cambridge School Certificate or GCE "O" Level at one and the same sitting; and
- ii) Certificate in Draughtsmanship;

**OR**

An alternative qualification acceptable to the Board;

**AND**

- iii) Reckon at least 3 years' experience in Draughtsmanship.

#### Salary Scale

Rs 24,400 x 675 – 27,775 x 1000 – 36,775 x 1425 – 51,025 x 1700 – 52,725 p.m. + increases at approved rates

#### Main Responsibilities and Duties

#### Mode of Application

The envelope should be clearly marked with the enlistment / post applied for on the top left-hand corner.

8. Candidates applying for the position of Draughtsman or enlistment as Cadet Engineer are informed that a written test may be carried out to assess their proficiency and ability.
